## "Fire station baby" has had a "really good life"

Twelve years ago a couple drove up to a fire station door in Denver, handed a newborn baby to a firefighter, and then drove away.

Colorado has a Safe Haven law that allows a mother to drop her newborn baby off with a staff member in a designated "safe place," no questions asked. The fire station was a safe place and the little girl was now safe.

Fast forward 12 years. Hallie Burke, adopted by Julie and John Burke, made a video.

She is hoping that her "tummy mommy" will see the video and contact her. Hallie "wants to ask her about her life and thank her," because Hallie believes that she has had a "really good life."

She says, "Because there's a lot of women, people, who are afraid to have babies and when they do they make bad choices about it, but my tummy mommy made a really, really good choice."

## Pope's letter on the environment

Numerous news sources are lauding Pope Francis' new encyclical *Laudato Si*. In it, he advocates for those ecological measures that will make the global environment better for mankind. His acceptance of man-caused global warming lends urgency to his plea.

However, he also stresses the value of human life, saying:

120. Since everything is interrelated, concern for the protection of nature is also incompatible with the justification of abortion. How can we genuinely teach the importance of concern for other vulnerable beings, however troublesome or inconvenient they may be, if we fail to protect a human embryo, even when its presence is uncomfortable and creates difficulties? "If personal and social sensitivity towards the acceptance of the new life is lost, then other forms of acceptance that are valuable for society also wither away".[97]

## New York Times: overpopulation not a problem after all

Overpopulation, a concept popularized by Paul Erlich, has been accepted by the media as a true threat for many years, even in the face of data showing that under-population is a greater threat. Overpopulation has been the excuse to foist contraception and abortion on people who would prefer not to use them.

After years of advocating for population control, the NY Times has finally rejected the alarmist overpopulation idea, and put on their website a video explaining why there was no need for panic after all.

Unfortunately they do not mention the aggressive and frequently violent methods of population control currently in use today: forced abortion in China, mass sterilization in India and Uzbekistan, and the female abortion and infanticide that have produced gender imbalance in multiple countries. Nor do they discuss the hazards of a population deficit. However, this is a step in the direction of reality.

Although Paul Erlich has not changed his views, there are now more voices supporting an alternative analysis. Stephen Mosher of the Population Research Institute (<a href="www.pop.org">www.pop.org</a>) follows population trends around the world and demonstrates that we face a demographic winter of too few people, rather than too many.

## Belgian doctors "killing patients who have not asked to die"

According to the British *Daily Mail* about one in every 60 deaths in Belgium is the result of action by general practitioners on patients who did not request to die. The new report by Rafael Cohen-Almagor in the *Journal of Medical Ethics* says that two thirds of the patients, although in the hospital, were not suffering from a terminal disease.

The most disquieting fact in the report is that very often doctors did not discuss the matter with the patient or the families. They considered it "a medical decision to be made by themselves alone."

In Belgium, euthanasia can be administered only to a patient who is competent and who has requested it. Therefore, those deaths are completely illegal, but they seem to be tolerated by the medical profession and the general public.

Cohen-Almagor concluded his report by asking: "If Belgium has been unable to control abuse—and does not seem to have tried very hard—what reason is there to believe it will be controlled in the future?"

#### The Terri Schiavo of France

Frenchman Vincent Lambert, 39, suffered severe brain damage after a motorcycle accident. He breathes normally but receives food and water through a tube. His parents and some of his siblings say he responds to them and they believe he needs more and better treatments. Yet, his wife and some other siblings think he should be deprived of food and water.

On June 5, a court ruled in favor of such deprivation. A video shows Lambert's response to the news and the intense attention he later focuses on a brother who is speaking to him. His friend, narrating the video, points out that there are 1,700 other patients like Vincent. He says "Vincent is not at the end of his life. It's that, that we really must understand."

He is called the Terri Schiavo of France. Terri's brother Bobby Schindler agrees.

"This case parallels my sister Terri's case in so many ways," says Schindler. "Vincent's family is fighting for his life, wanting to continue therapy. Since Terri's death, there have been dramatic breakthroughs in treatment and promise of new technologies on the horizon. There are documented cases in which brain-injured patients become capable of moderate levels of consciousness and actually regain some level of functionality. There are also cases on record where such patients regain full functionality and today live active, independent lives."

## **Euthanasia by gun OK?**

A fall at home left William Dresser's wife permanently paralyzed. She was despondent and said she didn't want to live. So William Dresser visited her in the hospital and shot her to death.

District Attorney Jason Woodbury dropped all charges, explaining, "I didn't view there being any component of evil to his act of killing."

As attorney Wesley J. Smith said, "To do nothing about a blatant homicide devalues the lives of paralyzed people and sends a loud message that homicides of the elderly, sick, and disabled to relieve suffering are of less serious societal concern than the killings of other citizens.

"But it does show that euthanasia is not really a 'medical act' if it is okay for a husband to carry out such a killing with a gun."

## **Commodification of embryos**

After many years of in vitro fertilization techniques including egg donations, many frozen embryos await some kind of disposal. If the parents are not planning more children, these embryos will not be implanted unless they are donated to someone else. There are several programs designed to match up available embryos with people who want them.

However, some of the programs eventually found that they did not have enough embryos to meet the demand. Dr. Ernest Zeringue instituted a program called California Conceptions. His clinic buys eggs and sperm from attractive people, then combines them to make embryos. His clinic charges a patient \$12,500 to use these embryos in an effort to become pregnant and it is understood that eggs and sperm will be used for more than one patient.

Critics of his program are concerned about producing embryos for whom there is no family waiting. Other critics call his program the Costco approach and say his process is the commodification of small humans. They also point out the danger of unsuspected genetic relationships between people who may later reproduce.

## Albany: New York State Legislation Assisted Suicide

Mercifully, there is currently no movement on any of the assisted suicide bills and the session is drawing to a close.

The cartoon at the right hits the nail on the head. Apparently suicide is a terrible choice unless you are defective in some way, in which case it's understandable and we need to help you do it.

#### **Denial of Treatment**

There were several bills introduced in the New York State Senate that would have made it easier for a patient in New York to be labelled with a Do-Not-Resuscitate order without necessarily consulting the patient. Thankfully, these bills were all withdrawn by the sponsor, so at this time there is no concern about them.

## Washington: Federal Legislation and Regulation Pain-Capable Unborn Child Protection Act

The Pain-Capable Unborn Child Protection Act was introduced in the U.S. Senate on June 11 by Senator Lindsey Graham as S.1553. It has been referred to the Senate Judiciary Committee. It has 45 cosponsors, all Republican.

The Act, as H.R. 36, had passed in the House of Representatives on May 13 by a vote of 242-184.

NRLC says, "This legislation would extend general protection to unborn children nationwide beginning at 20 weeks fetal age, based on congressional recognition that by this point in development, if not earlier, the unborn child is capable of experiencing pain. The legislation is based on model legislation developed by National Right to Life, already enacted in 11 states."

## **Abortion drones**

Women on Waves, an organization designed to circumvent protective restrictions certain countries have placed on abortion, is now planning something new, based on what they see as a need in Poland. In Poland, abortion is restricted to cases where there is a serious health threat, cases of rape or incest, and serious fetal problem.

They plan to fly an abortion drone from Germany into Poland, carrying mifepristone and misoprostol, which are illegal in Poland. The drone will be unloaded and the contents distributed after it lands in Poland.

Women's health can't be the real need, since Poland's maternal mortality rate is better than the rate in the US. Poland is close to the top, with only 5 maternal deaths per 100,000 live births. The US is listed as having 21 maternal deaths per 100,000 live births. (2010 data)

## Planned Parenthood: abortions up, non-abortion services down

A new 41-page report by Americans United for Life points out that Planned Parenthood's (PP) mega-centers coincide with an increasing focus on abortion. Other AUL points:

- The number of abortions performed by Planned Parenthood has increased along with the addition of the mega-centers by more than 70,000 abortions annually.
- Planned Parenthood mega-centers strategy coincides with its increasing share of the abortion market: from performing 20 percent to at least 32 percent of all abortions in the United States.
- Many of Planned Parenthood's non-abortion services (including cancer screening and other preventive services) have simultaneously declined by more than 50 percent.

## Vietnam to drop birth restrictions

Vietnam has had a two-child policy for many decades, enforced by economic coercion and by sterilizing women after the birth of their second child. PRI comments that the birth restrictions were loosened in 2003 but reinstated in 2009. However, it appears that the restrictions will be eliminated. The shift in policy probably results from serious concern over the country's "precipitously falling birthrate."

This government measure may or may not solve their birthrate problem. Japan, for instance, encourages pregnancy by offering bonuses. It has not so far been a success.

## **UN committee has a problem**

The UN Human Rights Committee has for years worked to develop UN language to support abortion as a basic human right. The committee had asked for written contributions ahead of the discussion of the right to life to be held this summer.

C-FAM said, "Over 30 organizations from around the world urged the committee to recognize the right to life of unborn children, or at least not recognize a right to abortion." They add, "Of 55 interventions published on the committee's website, only two, from Amnesty International and the Center for Reproductive Rights, call for abortion to be recognized as a human right." What a surprise that must have been for the Committee!

One of the organizations, Autistic Minority International, noted the prenatal screening and subsequent abortion of children with handicaps and voiced their concern that such a process would be carried out in suspected prenatal autistic individuals.

CEO Maynard Howe, no relation, had a chance to correct the record, to say that the stem cells did not come from "adult volunteers," but he failed to do so. He commented later, "We don't use the word 'fetal' too much. We just don't want to get people confused about what it is."
