### Eliminating more handicapped babies to save money

The UK Royal College of Obstetricians and Gynaecologists (RCOG) recommends a "rigorous economic analysis" to decide whether to roll out the non-invasive prenatal testing (NIPT) that would identify genetic abnormalities like Down's Syndrome.

NIPT screens a mother's blood for fragments of DNA from the baby and hence eliminates the testing risk to the baby. The cost savings would occur because knowledge of the presence of Down's syndrome would cause many parents to decide to abort their offspring.



The NIPT discussion has generated a movement in Britain called "Don't Screen Us Out." Heidi Crowter, a 20-year-old hairdresser with Down's syndrome, did a rally speech that has gone viral. She said, "...my life is just as important and just as joyful as anyone else's." She also asked the lawmakers, "Don't screen us out."

In the late 1950s Dr. Jerome Lejeune discovered that Down syndrome was caused by the presence of an extra 21st chromosome. He meant for his discovery to be used for good. He was horrified that his discovery was being used to develop methods of detecting Down syndrome in the womb for the purpose of eliminating these innocent lives.

Lejeune said "Medicine becomes mad science when it attacks the patient instead of fighting the disease. We must always be on the patient's side, always."

### Legal push to starve a dementia patient

Canadian courts ruled some time ago that a woman with dementia must be spoon fed, that she signified her consent every time she opened her mouth for the spoon.

That fight has come to the US.

Bill Harris tried to prevent the nursing home from spoon-feeding his wife Nora, a nursing home patient with early-onset Alzheimer's. He said his wife had said she didn't want her life prolonged and he was sure she would object to the spoon feeding if she could. The court, however, said that she must be assisted to eat. She had been feeding herself earlier, when she was able.



Advance directives are intended to handle medical decisions. So far the use of a spoon has not been defined as "medical." Nursing homes are required to keep patients warm, dry, clean, and fed. As Wesley, J. Smith says, "Who will go into that caring profession if they know they could be forced to starve patients to death who not only can eat, but may want to eat?"

Harris does not plan to appeal the decision because he thinks his wife will be gone long before the appeals process would be decided.

### India's sterilization camps ordered closed

Sterilization of women has long been a part of India's efforts at population control. States are rewarded for achieving targets, which are often dependent on "sterilization camps," where many women are sterilized under unsanitary conditions, with inadequate or nonexistent medical care afterwards.

India's Supreme Court has now ordered that all sterilization camps be closed within three years. It also urged much better compensation for botched procedures and directed that the central government be accountable for assuring that state governments follow proper protocols, including the gathering of data.

The Population Research Institute (PRI) points out that corruption is endemic in the program, because state governments set targets for number of sterilization and may reward the best-performing areas. Women are offered the equivalent of \$21 to be sterilized, but are not warned of the dangers. The Court mandated that such warnings were to be given in the woman's own language, even though there are at least 122 major languages spoken in India.

PRI says that although this is "a step in the right direction," the central government "must eliminate the system of bribes and incentives that drive the program." #### Adult stem cells and TBI

Dr. Charles Cox, the co-director of the Red Duke Memorial Hermann Trauma Institute, has received a \$6.8 million grant from the Department of Defense to study the use of adult stem cells in adults with traumatic brain injury. The stem cells in this study will be those from the patient himself. Adult stem cells have been used for many purposes, e.g. healing corneal damage, facilitating the healing of broken bones, improving circulatory system functioning in extremities, and restoring immune systems after cancer treatment. Traumatic brain injury is a new area.

Dr. David Prentice, stem cell expert, comments, "The hope, based on previous studies, is that the adult stem cells will help stabilize the brain after trauma as well as decrease any inflammation or secondary effects that could lead to brain damage."

### Schneiderman has a pen, too

In a newsletter from New York's Attorney-General Schneiderman, Schneiderman comments on a legal opinion he has published. His newsletter says:

"This week, Attorney General Schneiderman made it crystal clear that all women have a constitutional right to an abortion. In a formal legal opinion, the Attorney's General office clarified that New York laws cannot interfere with the reproductive health protections afforded to all women pursuant to Roe v. Wade and subsequent U.S. Supreme Court decision. The opinion eliminates any legal ambiguity about New York's laws, and removes an obstacle some New York women may encounter when making personal reproductive health decisions."



According to the newspaper account, this legal opinion is a step towards allowing the standard exceptions of mother's health and fetal viability. Pro-life organizations see the "health of the mother" as a provision that will be used to justify abortion on demand with no limit on gestational age of the fetus.

### Gallup says Americans pro-choice. True?

Gallup's headline was "Americans choose "pro-choice" for first time in seven years." But, not so fast. For the last seven years, sometimes the largest numbers of Americans described themselves as pro-life and in other years more described themselves as pro-choice. So does that mean that Americans have decidedly moved to a pro-choice position?

A recent poll by the Marist Institute for Public Opinion looked at more specific aspects. They found, for instance that about 78% of Americans, including some who say they are pro-choice, would limit abortion to the first three months of pregnancy. Only about 1 in 10 Americans supports the limitless abortion advocated by many of the political and feminist leaders of today. The others are closer to the pro-life position.

So, are Americans pro-choice? If you just look at labels, maybe. ### Zika, mosquitos, and microcephaly

In June, the New England Complex Systems
Institute (NECSI) published a paper on the
microcephaly epidemic in Brazil. Women who were
pregnant and got the Zika virus from a mosquito bite
tended to have babies with smaller head size than normal, with
accompanying handicaps.

They quoted 1,500 confirmed cases of microcephaly in Brazil. However, in neighboring Colombia, there were no cases of microcephaly in in a study of 12,000 pregnant women infected with Zika.

The NECSI suggests therefore that the virus itself does not seem to be the cause. The pesticide pyriproxyfen was used in some places in Brazil to kill mosquito larvae of the mosquitos that carry Zika. It was also added to the drinking water in one state. Part of the chemistry of this pesticide is associated with microcephaly. Researchers are recommending further studies of the possible pesticide-microcephaly link. www.sciencedaily.com/releases/2016/06/160624150813.htm

### Rest in peace, Assembleyman Bill Nojay



Bill Nojay died by his own hand on September 9, 2016. Speculations surrounding his motivation were published by the local press. However, pro-lifers may remember him more for his scholarly approach to current issues, his pro-life commitment, and his kindness. He spoke to Rochester Area Right to Life's Annual Meeting two years ago. His remarks were captured at the time by RARTL reporter Susan LeDoux. She said.

As radio host and New York State Assemblyman, Bill Nojay has a bird's eye view of the political landscape, and he shared his observations at RARTL's 2014 dinner meeting.

He painted a picture of the tug of war between forces in government and our educational institutions that want to protect individual rights and those that feel the government should be the grand regulator. We are soldiers in a cultural war as well, fighting for the right to life from conception to the grave, care for the disabled, and no rationing of health care.

Fighting for the primacy of individual rights over government, Nojay warned, "If we aren't involved, others will be." We must re-gird ourselves, re-enter the battle and not give up.

### French plan to criminalize abortion opposition

The French government plans legal penalties of fines and imprisonment against websites that try to convince women against having an abortion. According to French minister Laurence Rossignol, the penalties will not be levied against those who are simply speaking against abortion, but only the pro-life sites that appear to be giving "complete and honest information on abortion" and who, presumably, might lead women to think twice about having an abortion.
