## The UK's new PM has voted pro-life

After the Brexit vote in Great Britain, Prime Minister David Cameron resigned and was replaced by Theresa May. She is the second woman appointed to the position, following the legendary Margaret Thatcher. ITV said she "has earned a reputation as a tough and experienced political operator with a thick skin and traditional conservative views..."

The new prime minister has a history of voting with the pro-life lobby, according to the Society for the Protection of Unborn Children (SPUC). Paul Tully, their General Secretary, points out that she has so voted on issues of embryo research, sex-selective abortion, and assisted suicide. Possible negatives include speaking in support of mandatory sex education.

SPUC said that "Pro-lifers will continue to watch as the new government continues to take shape and ministerial appointments are announced."

## **Abortion on Demand**

The 1973 Roe v. Wade and Doe v. Bolton Supreme Court decisions legalized abortion on demand throughout the United States. There have been more than 59 million abortions since then.

"Let me be clear -- I am pro-life... I did not always hold this position, but I had a significant personal experience that brought the precious gift of life into perspective for me." In 2003, Hillary Clinton voted to endorse *Roe v. Wade*, which allows abortion for any reason. In 2016, Clinton said, "The unborn person doesn't have constitutional rights," later adding she believed this to be true even on the unborn child's due date.

## **Partial-Birth Abortion**

The partial-birth abortion procedure -- used from the fifth month on -- involves pulling a living baby feet-first out of the womb, except for the head, puncturing the skull and suctioning out the brain. The Partial-Birth Abortion Ban was upheld by the U.S. Supreme Court in 2007, in a 5-4 decision.

In 2000, in his book *The America We Deserve*, Donald Trump wrote that after consulting with doctors about the partial-birth abortion procedure, he concluded that he would support a ban on that method.

In 2003, Hillary Clinton voted against the Partial-Birth Abortion Ban Act (voted to allow partial-birth abortions to continue) every chance she got.

## Nominations to the U.S. Supreme Court

The next president may have the opportunity to appoint three or four justices to the U.S. Supreme Court.

In May 2016, Donald Trump released a list of eleven conservative judges whom he would consider for a Supreme Court vacancy, saying, "By the way, these judges are all pro-life."

Hillary Clinton has said that she would only nominate Supreme Court justices who would uphold the decision that legalized abortion on demand. "I would not appoint someone who didn't think *Roe v. Wade* is settled law."

#### **Vice Presidential Candidates**

## **Mike Pence**

Mike Pence had a solid pro-life voting record on abortion during 12 years in the U.S. House, including votes for passage of the Partial-Birth Abortion Ban Act. As governor of Indiana, Mike Pence championed many pro-life measures.

#### **Tim Kaine**

Tim Kaine voted against the pro-life position in the U.S. Senate every chance he got. He voted against the Pain-Capable Unborn Child Protection Act. Tim Kaine co-sponsored a bill (S. 217) that would nullify virtually all state limits on abortion, including late abortions.

## **Party Platforms**

The Republican Party Platform affirms "that the unborn child has a fundamental right to life," opposes using government funds to perform or promote abortion or to fund abortion providers, and supports legislation to assist babies who survive abortion.

The Democratic Party Platform supports abortion on demand, and calls for repeal of the Hyde Amendment (which restricts the use of federal funds for abortion). The platform also supports government funding of abortion providers, including Planned Parenthood, the nation's largest abortion provider.

#### AMA to reconsider assisted suicide policy

In June, the American Medical Association (AMA) decided to study the possibility of taking a neutral position on doctor-assisted suicide. They had always firmly opposed it in the past.

Dr. Jeff White, of the Louisiana State Medical Society, said after the vote that such a change threatened "the future of the integrity of the medical profession" and, among other things, "could have a lasting negative impact on … the doctor patient relationship of trust, and the true autonomy of underprivileged persons."

#### Belgium and the Netherlands combining euthanasia and organ donation

Many people in the US have signed up to donate their organs after death for transplanting. Occasionally the dying people in the hospital are pushed to sign organ donation forms, because the transplant teams feel the urgency of the whole process. Sometimes because of the urgency, the pressure on patients becomes downright unethical.

That is one ethical issue.

However, there's an additional problem, a conflict of interest, in Belgium and the Netherlands, where euthanasia by injection has become commonplace.

There, selected euthanasia candidates, who are not dying, are asked to go to a hospital rather than receive their lethal injections at home. At the hospital, they are killed in a room adjacent to an operating room. After being pronounced dead, they are then wheeled into the operating room for the organ removal.

One wonders: at any point, does any medical staff feel any responsibility for the well-being of the donors? Or are donors just spare parts?

One also wonders: does this process influence a doctor who is discussing the pros and cons of euthanasia with a patient? Does it help the doctor to regard the patient in a human being? Or does he find himself seeing this patient more as simply a collection of spare parts for somebody else?

#### **Remember little Simon Crosier?**



You met him in the spring issue of LifeLines.

Simon's mother and father gave a talk at the National Right to Life Convention in July of this year, where it was very sympathetically received. Probably everyone there could understand the agony of having a new baby with medical problems and discovering that the doctors were not really trying to help him.

In later communications, Sheryl Crosier reminded RARTL that Simon needed heart surgery, not brain surgery. Heart problems are common with Trisomy 18, as is apnea. The

Adivan, which he was given twice before he died, is contraindicated in apnea.

Other parents, faced with a poor prenatal diagnosis of trisomy, can begin to educate and equip themselves by going to <a href="https://www.trisomy.org">www.trisomy.org</a>, also known as SOFT (Support Organization for Trisomy 18, 13, and Related Disorders).

Trisomy 18 is not an immediate, automatic death sentence. As a matter of fact, a new study out of Ontario, Canada, suggests that birth defects "are not always as lethal as doctors have advised parents." If you want to read an inspiring story, read about Donnie (<a href="http://trisomy.org/?our-story=donnie-heaton">http://trisomy.org/?our-story=donnie-heaton</a>), who died at 22 years old. And while you're there, look at those happy children on the landing page.

#### Planned Parenthood investigators cleared

A Texas judge dismissed the last charge (falsifying identification) against David Daleiden and Sandra Merritt. The Houston Chronicle said, "In a surprise move before a hearing on the legitimacy of the indictment, prosecutors dismissed the charges."

Daleiden, president of the Center for Medical Progress, had made a series of videos which he posted online. The videos showed Planned Parenthood personnel negotiating price with what they thought was a possible purchaser for body parts obtained from aborted babies.

An attempt was made to prosecute Planned Parenthood for selling baby body parts for profit, but instead the grand jury indicted the investigators for, among other things, falsifying government identification.

A House Select Investigative Panel on Infant Lives was convened and has produced information that Planned Parenthood has indeed made a profit from the sales. Planned Parenthood has, however, not yet been charged with breaking the law.

#### Single payer system to take away options?

"U.S. District Judge Jean Hamilton ruled last week that the federal government cannot force Paul and Teresa Wieland -- an American mom and dad -- to violate their religious beliefs by compelling them to purchase a health insurance plan that covers sterilizations, contraceptives, and abortion-inducing drugs and devices."

Originally, the Wielands purchased a Missouri plan opting out of such coverage. However, Obamacare requirements later forced the company to include the coverage. The Wielands sued and were assisted through several appeals by their own lawyer and the Thomas More Society of Chicago.

However, it is worth noting that the Justice Department lawyers arguing the case say that there would be no opportunity for a religious freedom challenge in a single payer system where the government provides all the coverage and requires Americans to pay premiums. Time will tell, if the US goes in that direction.

#### Recent assisted suicide progress – not!

In Massachusetts a bill legalizing assisted suicide was "recommended for further review," which means it will not progress further. Three previous versions of the bill met the same fate and in all three, the bill failed to make it out of committee. A voter referendum also failed, but by a relatively narrow margin.

By a 5 - 0 decision, the New Mexico Supreme Court upheld patient protection from assisted suicide. In 2012 by two doctors, who were then joined by a stage-3 cancer patient with a terminal prognosis, initiated the case, challenging the 1963 Suicide Act. The cancer patient, Aja Riggs, is now in remission.

#### Castorina's maiden voyage hits stormy weather

Freshman Assemblyman Ron Castorina gave what was reported as his "maiden" speech in the New York State Assembly opposing an expansion of abortion in NY State. After he referred to the effects of abortion as "African-American genocide," Democratic and black Assembly members took turns asking him to yield his time so they could object to what he was saying. They also did not like his statement that, but for abortion, "the African-American community would be 36% larger today." To each yield request he said, "Respectfully, no."



One member, Democrat Diana Richardson, said she was offended "as both an African American and a woman" and hoped that future conversations would be more respectful.

But is it not respectful to bemoan needless loss of innocent human life? Castorina's offensiveness was not a lack of respect. It was that he dared to speak in forthright disapproval of the needless loss of life in abortion.

- Celebrate the lives saved by the Hyde Amendment and the lives of all Medicaid kids.

- Expand the Hyde Amendment to cover children in every state and children conceived through violence, and cut the abortion industry off from all sources of taxpayer funding (not just Medicaid).

## Supreme Court protected predators, not women

The Supreme Court ruled against women's welfare in Whole Woman's Health v. Hellerstedt.

The Texas suit resulted from legislation to put the same health and safety standards into abortion centers as there are in ambulatory surgical centers. It was prompted by the horrifying Gosnell case in Philadelphia, where investigators found themselves in a situation of squalor that included fleas and blood stains. The standards were the ones recommended by the Grand Jury that investigated Gosnell.

The provisions struck down were the requirements for health and safety standards and also the requirement that abortionists had to have admitting privileges at a hospital no more than 30 miles away so that they could provide continued care to patients in case of complications. The ruling held that these provisions constituted an undue burden for women seeking abortions.

The "undue burden," for instance, of minimum corridor width isn't obvious under normal circumstances. However, it can cost precious minutes if an ambulance crew discovers when they arrive for an emergency transport that their gurney will not roll around a corner.

Ryan Bomberger said, "Texas moved to protect women. The Supreme Court moved to protect the predators."

Dr. John Bruchalski, of Divine Mercy Care, in a letter, marveled, "There are those who wish to regulate lemonade stands but not abortion clinics; it doesn't make any sense."

He's right. It really doesn't make sense.
